Present were Chairman Rick Tonini, Secretary Kathy Wrigley, Treasurer Nick Heilmann, Trustee Mike Abell, Trustee Christine Kesler, and Trustee Chris Mooser. Also present were Chief Nicholas Clark, Assistant Chief David Howser, Assistant Chief Stuart Monohan, Assistant Chief Mike Riordan, Human Resource Manager Michael Frantz, Attorney Mark Leach, Accountant Robin Roberts, and Administrative Assistant Terri Livers.

Chairman Tonini called the meeting to order at 4:04 PM.

The minutes for the December 8, 2022, meeting were approved by motion of Secretary Kathy Wrigley. Second by Trustee Christine Kesler. Motion Carried.

**Treasurer's Report**

Accountant Robin Roberts referenced the Comments to Financials distributed with the board package. Approval of the December expenditures were motioned by Trustee Mike Abell. Second by Trustee Chris Mooser. Motion Carried.

**Old Business – None**

**Fire Chiefs Report**

- *Recruit Firefighter Update* – Chief Clark informed the Board that the recruits are doing well and are beginning the fire portion of their class. All but one had passed their EMT certification as of this report.
- *ARPA Fund Update* – ARPA premium pay for our employees and volunteers that worked through the assigned COVID period, and are still employed or volunteering with the district, processed last month from Louisville Metro with combined support from the small cities.
- *New Quint* – Final inspection in two weeks with delivery of the unit expected in February. All the necessary equipment will still need to be added before it can be placed into service.
- *Exhaust System* – The installation work is underway. Station two is complete.

January 12, 2023, Trustees Meeting

- *Bay Heaters* – Another quote will be requested for comparison purposes. It is hoped that the expense can be delayed until FY 23/24.
- *Emergency Service Careers* – Chief Clark and others from the command staff will be visiting Waggoner High School on January 24<sup>th</sup> or January 31<sup>st</sup> to talk with the students about possible careers in fire and EMS.
- *Email* – Chief Clark asked those members that are interested to contact him if they would like to have, and would use, a department email address.
- *Updates/Statistics Fire & EMS* – Assistant Chief Riordan reviewed December 2022 EMS statistics, including a new report on the percentage of runs that the department makes by district.
- Chief Clark mentioned a particular house fire that the department responded to last month, during the extremely adverse weather conditions and how difficult that run – among many others that weekend, were on the responders. All were commended for a job well done!

**New Business**

- *FSA & HRA Annual Corporate Resolutions* – Corporate resolutions prepared by BMS (Benefit Marketing Solutions), the district's third-party administrator for employee FSA and HRA accounts, were provided with the board packages. Motion of approval by Treasurer Nick Heilman. Second by Secretary Kathy Wrigley. Motion Carried.
- Trustee Kathy Wrigley asked if the department had a written policy on take home vehicles. Chief Clark and Assistant Chief Monohan will draft a policy for department implementation.

## Fire Dept.

### Under New Leadership, St. Matthews Fire and EMS are Crossing Boundaries

Chief Nick Clark, who was hired as the St. Matthew's Fire District's new Fire Chief after the retirement of Chief Bill Seng, hit the ground running—addressing the challenges faced by modern Fire and EMS services across the country. For Chief Clark, hiring the replacements for the vacant positions created by retirements was a priority to ensure the district maintained minimum staffing. On October 3, 2022, a first-time initiative for the district came to be a reality through collaborative efforts with neighboring Anchorage Middletown Fire and EMS (AMFEMS).

In August 2022, St. Matthews Fire and EMS accepted applications from civilians with no formal fire background or training. Receiving over forty applications, the applicants were administered an online proctored general knowledge test at Trinity High School. After written testing, Candidate Physical Agility Testing (CPAT), and oral interviews, the finalists were offered employment to join the recruit academy.

In partnership with AMFEMS, the six newly hired recruits began their career in fire service on October 3, 2022, at the Fire Academy hosted by AMFEMS. Through this partnership and working with a neighboring fire district, the taxpayers of St. Matthews saved significant money by sharing costs and resources.

After the 26 weeks of academy training, the new fire recruits will graduate as certified Firefighter EMTs, holding many national certifications. Each day, the recruits participate in

daily physical training, lectures from the instructor cadre, and develop their skills to become well trained and educated firefighters that will serve our community with pride for years to come. Currently, the recruits are preparing to take their National Registry Emergency Medical Technicians (NREMT) exam and will begin fire training in January. The recruit class is expected to graduate in late April and begin serving our community by early May 2023.

Chairman Tonini called the meeting to order at 11:05 AM.


**Special Service Vehicle Purchase**

Chief Clark presented a purchase request to the board that was made necessary due to limited availability. The department needs a replacement vehicle for the current 2605. Supply and demand are making the process difficult for planning purposes. Vehicles placed on order now are estimated for delivery in late 2024 or early 2025. Bachman Chevrolet has one Chevy Tahoe available at the state contract price of \$45,147.92 that they have agreed to hold until this afternoon. The board discussed the current need, budgeting for projected vehicle and apparatus replacement, as well as take home vehicles. A request was made for tracking of "from home" responses. Chief Clark agreed to provide that information.

## Man killed in Blankenbaker Lane crash identified by officials

LOUISVILLE, Ky. (WAVE) - Officials have identified the 64-year-old man killed in a crash in the Indian Hills neighborhood on Friday night.

Anthony Renfro died from blunt force injuries sustained in the crash, according to the Jefferson County Coroner's Office.

Louisville Metro Police spokeswoman Alicia Smiley said the LMPD Traffic Unit, along with the Indian Hills Police Department, responded to a report of a single vehicle collision in the 100 block of Blankenbaker Lane shortly before 8 p.m.

The man was transported to UofL Hospital where he was pronounced dead.

According to officials, preliminary reports show that the man lost control for some unknown reason and struck a tree while traveling southbound.

Smiley said the man was the only person in the vehicle.

Officials said they do not believe weather was a factor in this incident. Investigation is ongoing.

## Crews extinguish fire at historic home near Forest Hills car dealership

LOUISVILLE, Ky. (WAVE) - Crews are investigating following a fire close to a car dealership near Jeffersontown on Friday night.

Around 5:40 p.m. on Friday night, crews were called to a structure fire in the 2100 block of South Hurstbourne Parkway, Jeffersontown Fire Department Chief Sean Driesbach confirmed.

Driesbach said the call originally came in for the Buca di Beppo restaurant, but upon arrival, crews noticed the fire coming from a historic home connected to the ZadCarz dealership.

Heavy fire was reported from the first floor of the home; and Driesbach said crews worked to stop the fire from extending to the second floor and to the dealership itself.

No one was in the home at the time of the fire.

Around 40 firefighters from Jeffersontown, Fern Creek, St. Matthews and Anchorage-Middletown were on scene, Driesbach confirmed.

"All firefighters are fine," Driesbach said. "We had one firefighter who had a trip, but he's OK."

Driesbach said he was unsure if the weather caused the fire, but said weather can cause difficulties to contain fires.

"A small little fire, it doesn't take much... like a cigarette butt," Driesbach said. "A little bit of wind will push that cigarette butt and actually cause that fire to build."

Investigators are working to determine the cause of the fire.

## No one injured after historic building in Forest Hills neighborhood catches on fire

LOUISVILLE, Ky. (WDRB) -- No one was injured after a historical home connected to a car dealership in Louisville's Forest Hills neighborhood caught on fire Friday evening.

Sean Dreisbach, the chief for Jefferson County Fire, said firefighters initially responded on a call for a fire at Buca di Beppo around 5:30 p.m. But the fire actually occurred in the 2100 block of South Hurstbourne Parkway at a historical home that's connected to a car dealership.

Dreisbach said there was heavy fire on the first floor and firefighters made sure with the heavy winds from Friday that it didn't extend to the second floor or go into Zad Carz.

Firefighters from Jeffersontown, Fern Creek, St. Matthews and Anchorage all responded to the fire. No firefighters were injured as well.

The fire is currently under investigation and it's unknown if it was caused by the severe weather.

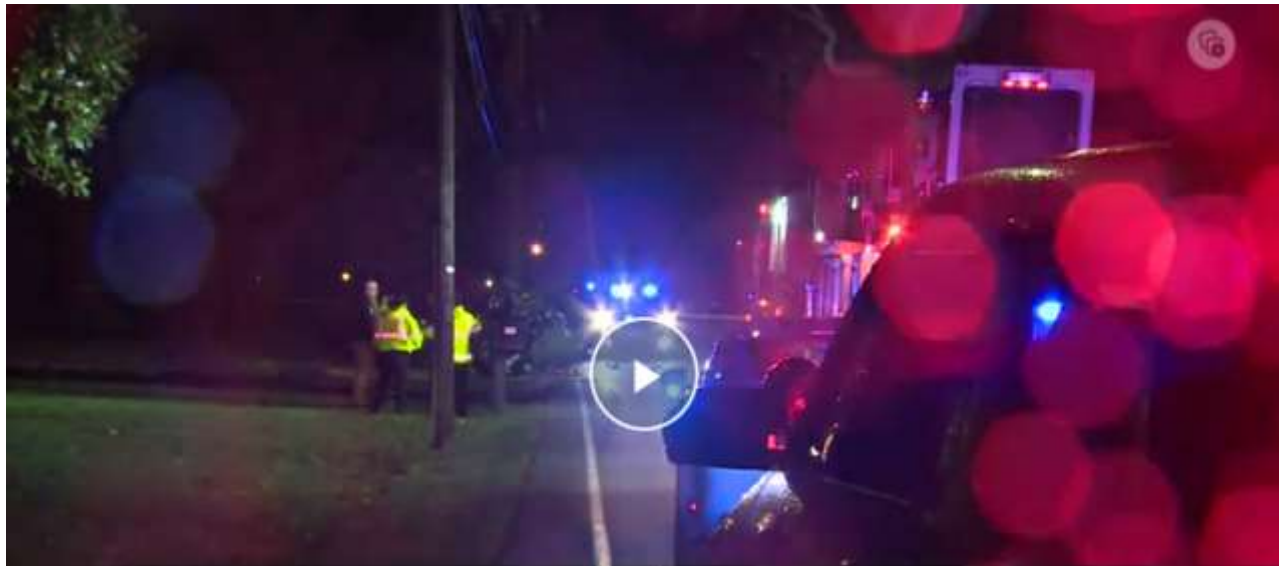

## 64-year-old Lyndon man dies after crashing into tree



**LOUISVILLE, Ky.** — A man was killed after a crash in Indian Hills Friday evening.

It happened just before 8 p.m. on Brownsboro Road where it Blankenbaker Lane meets it.



Louisville Metro Police said 64-year-old Anthony Renfro of Lyndon was driving south on Brownsboro when he lost control of his car and struck a tree.

Renfro was taken to UofL Hospital, where he later died.

Police said they don't believe the crash is weather related, as the region saw [dangerous conditions](#) during all day and evening severe weather.

Thunderstorms that brought high-speed winds through the region Friday left a mark in Louisville and around the Bluegrass State – and left plenty of work to be done Saturday.

About 81,000 people in Louisville alone were without power by 5 p.m. Saturday, according to LG&E's online outage map, with tens of thousands without power in surrounding counties. Those city residents were among the more than 332,000 people around Kentucky who did not have electricity at that time, according to poweroutage.us, an online aggregator.

Power restoration will be a "multi-day" process, LG&E spokesperson Liz Pratt said Saturday morning. The storm was the third-most significant power outage event in the past 20 years, she said at about 11 a.m. The company had a total of 190,000 customers in Louisville and the surrounding region without power at that time and has dealt with 80,000 calls since the start of the storm.

Friday's storm brought heavy rain through the commonwealth followed by devastating high-speed winds, which peaked locally at 79 mph, according to the National Weather Service in Louisville. At least five people across the state had been killed due to the severe weather, though Louisville Metro Emergency Services Director Jody Meiman said Saturday no deaths had been reported in Louisville.

Speaking at a Saturday morning press conference, Louisville Mayor Craig Greenberg said 75 roads around town are currently blocked by downed trees, but all routes should be open by the end of the day. Flood barricades that had been set up earlier Friday as rain rolled through have been removed, he said, and Greenberg urged anyone dealing with damage to contact insurance carriers in the meantime. The mayor added he should have more information about potential federal help in coming days.

**Treasurer's Report**

Accountant Robin Roberts referenced the Comments to Financials distributed with the board package. Approval of the February expenditures were motioned by Trustee Christine Kesler. Second by Trustee Mike Abell. Motion Carried. It was also noted that the district is now enrolled in the Positive Pay service with Stock Yards Bank, effective March 1, on the operating account.

**Old Business**

*Architectural Plans: Station 1 Bunk Room* – Plans have been developed and prepared for contract bidding. Costs should be available for board consideration at the April meeting, for possible inclusion in the FY 23/24 budget.

*Vehicle Policy Manual* – Trustee Kathy Wrigley distributed a policy manual for the board to review prior to the April meeting. With regard to vehicles, Trustee Chris Mooser asked if the district has a policy in place involving the use of unmarked command cars. Chief Nicholas Clark advised that he would develop a plan for the board to review.

In addition to the vehicle discussion, specific to take home cars and the benefit they may provide, Trustee Mooser mentioned the revolving four-day work week that is in place for some of the day staff personnel. Chief Clark did not know the origin of the four-day rotation but will research the history of it, and explained that he and at least two chief officers are always on the weekday schedule. A battalion chief is on duty 24/7.

### New Business

*Establish Election Committee for June 24 Election of Firefighter Trustee Election* – Secretary Kathy Wrigley, Treasurer Nick Heilmann and Trustee Mike Abell volunteered to serve on the election committee.

*Terms expiring June 30, 2023:* FF Representative Nick Heilmann and Mayoral Appointed Christine Kesler. Trustee Heilmann will not be serving another term. Trustee Kesler is not opposed to reappointment. Chairman Tonini expressed his support of Christine's continued service, given her background as a CPA and oversight for the board.

*Crew Awards Breakfast* – Chief Nicholas Clark reported that the district has provided, with the assistance of Trustee Kathy Wrigley, Major Rick Baker, Major Tracy Jevning, and HR Manager Michael Frantz, an opportunity for all employees to attend a breakfast and awards recognition on March 8, 9, and 10. Chief Clark explained that there has not been an official awards ceremony for the last few years and the FY 22/23 budget did not allow for one this year.

*Long Term Strategic Plan* – Chief Nicholas Clark reported that he and others would be working with Trustee Christine Kesler to develop a long-term strategic plan. Trustee Kesler advised that the information to be gathered and assimilated will take at least six months to prepare.

*2023 Kentucky General Assembly / Legislative Review* – Chief David Howser provided a summary document of 22 bills that the Kentucky Fire Chiefs Association is following, in this short session. One of the filed bills that will have a negative impact on fire district (SPGE) revenue, would remove the vehicle tax assessment if passed.

*By-Law Review* – Attorney Mark Leach provided an electronic version of the by-law review to the board, that he recently conducted of the 2013 document. The board members were asked to submit any questions or recommendation to his attention, prior to the April meeting.

### Fire & EMS Operation Report

*New Quint* – Delivery expected on Friday, March 10. Chairman Rick Tonini asked if there could be any discount in the delivery since the apparatus was driven to a recent fire school by the vendor.

*CAD Update* – The new CAD will be implemented between the hours of 0300 – 0600 on March 14. All of the suburban fire district unit numbers will be changed. Chief Nicholas Clark provided a short list of the new numbering system for St. Matthews FPD.

*EMS Statistics* – Assistant Chief Mike Riordan explained that there is an issue with ESO that limited access to our February response data. The upcoming CAD changes will likely impact the March data as well. Once the new CAD is functional, then efforts will continue with Louisville Metro to reduce the number of responses that St. Matthews continues to make well into the urban services district.



## Nearly 60 Anchorage Middletown firefighters battle structure fire

LOUISVILLE, Ky. (WAVE) - Crews with Anchorage Middletown Fire & EMS spent over an hour battling a structure fire Saturday morning.

Calls to dispatch reporting a structure fire came in around 9 a.m.

Jordan Yuodis with AMFEMS said crews arrived within four minutes and found a working fire that had been burning for some time.

It took about 60 firefighters 90 mins to get the fire under control due to the conditions inside the home.

Yuodis said no residents or firefighters were injured. The cause of this fire is still undetermined.

At 09:39 am today, AMFEMS, along with St. Matthews Firefighters, responded to a reported residential fire in the 4600 block of Deepwood Ct (Harrods Creek). Crews arrived on the scene in four minutes. When firefighters arrived, they found a working fire; crews made an aggressive push through the front door of the home.

Due to the heavy fire load and items inside the home, it made this operation difficult for firefighters. Shortly after that, command switched to offensive operations and then defensive.

Everyone made it out safely from the home. No injuries to firefighters, and the cause of this fire is undetermined. Crews remained on the scene for some time due to the extensive overhaul.

There is no word if anyone has died or is hurt from the crash, but the Kentucky State Police is at the scene of the crash and will provide an update shortly.

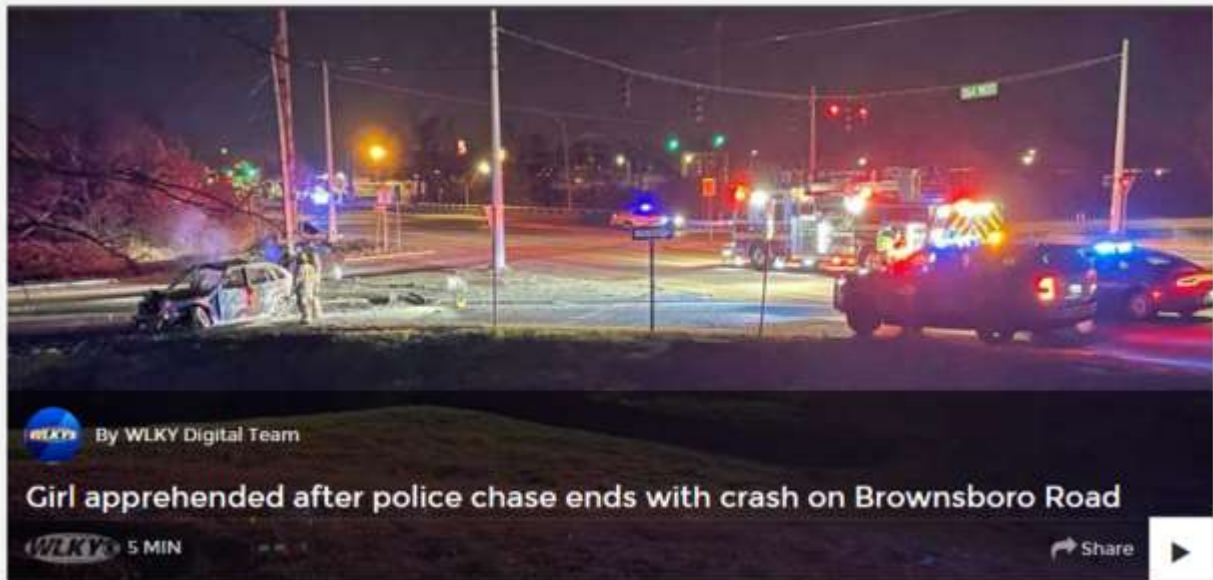

The American Red Cross will help those displaced, but TARC is helping shelter them for now.

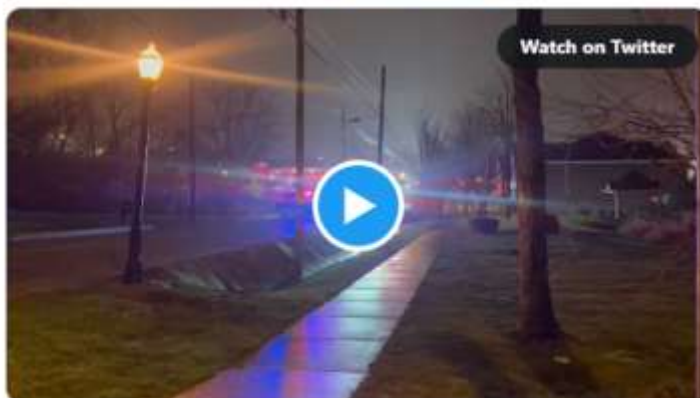

This is as accurate as I am aware of at this point. However, it is subject to change as they tweak the system and reassign vehicles and apparatus to different stations. I'll try to stay on top of that. Probably the biggest change will come on July 1, 2023 when Highview merges into Fern Creek. That will leave us with only 7 fire protection districts in Jefferson County. Back in our day there were 21!!!

*Alumni Reunion* – The STMFPD Alumni group has requested funding assistance for the reunion that is scheduled to take place on September 2, 2023. Chief Clark advised that he would include \$5,000 in the FY 2023/2024 budget proposal for the reunion.

*Teams for Virtual Board Meetings/ Video Conferencing* – Chief Clark explained that we will be using MS Teams for virtual board meetings and video conferencing going forward - when needed, rather than GoToMeeting. The department is using the full MS suite and there is no need to pay for the additional service through GoToMeeting. Major Crabb will be available to provide technical assistance if needed.

*Recruit Graduation* – The newly graduated class of recruits were welcomed and congratulated by the board of trustees! Their graduation ceremony and swearing in took place on April 10. Their 24/48 shifts will begin on Saturday, April 15.

*2023 Preliminary Assessments* – Chief Clark shared that he had received the preliminary real estate assessments earlier this day, and the total assessed value is less than expected. In fact, we are under \$18,407 from last year's preliminaries. The July reduction of our CERS employer contribution rate will help, but those savings will likely be offset by rising health insurance costs. A draft of the 23/24 budget proposal will be presented at the May 11 board meeting.

*Vehicle Policy Manual* – Chief Clark reported that he had pricing of \$1,500 - \$2,000 dollars per command vehicle for striping, if the board would like to see the vehicles have more of a visual presence for St. Matthews Fire & EMS. Unmarked command cars have been the trend for the last several years in Jefferson County. Additional LED light packages have been added for safety. The board agreed that operations should be at the discretion of the fire chief and deferred to Chief Clark for his professional guidance in matters regarding vehicle usage and employee scheduling.

### **Fire & EMS Operation Report**

*EMS Statistics* – Assistant Chief Mike Riordan provided the statistics that were available for March, but explained that the data is limited, and in some cases, unavailable due to the new CAD implementation on March 13. We will give it some time to hopefully work the bugs out before taking our (JCSFS) concerns to MetroSafe. It was noted that 43% of our EMS responses were out of the district in March.



This decision comes after 42+ years of dedicated service to the department, our community, and the greater commonwealth.

Chief Howser started his journey as a volunteer firefighter with the Lyndon Fire Department while still in high school in 1980. He was hired as one of the first career firefighters of the Lyndon Fire Department in 1984 along with three other future fire service leaders like Jim Baker, Ron Mingus and John Stich. Since those early days as a firefighter, Chief Howser held various positions and took on varied responsibilities. Over the years, he served as a Vice President for the Jefferson County Fire Chiefs Association, a Vice President and Legislative Agent for the Kentucky Association of Fire Chiefs, and a board member of the Kentucky Fire Commission appointed by Governor Matt Bevin.

Chief Howser was instrumental in the merger of the St. Matthews and Lyndon Fire Protection Districts in 2018. In this merger, he demonstrated leadership and his unwavering commitment to the well-being of our community above his personal needs for the greater good of the fire departments and this community. In recognition of his proven leadership, he was named the Kentucky Fire Chief of the Year in 2018 by the Kentucky Association of Fire Chiefs.

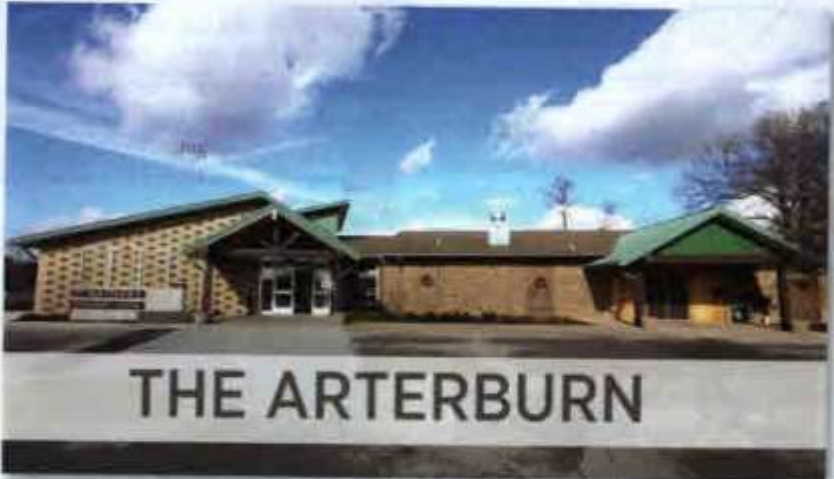

## Introducing The Arterburn

The Arterburn, formerly known as the St. Matthews Community Center, has undergone an extensive renovation and name change. The new name, The Arterburn, represents a return to its history, and honors the family that once owned the property that is now Community Park and the community center.

According to *St. Matthews—The Crossroads of Beargrass* by Samuel W. Thomas, Arterburn family patriarch William Arterburn Sr. (1745–1816) and his wife, Rachel Smoot Arterburn (1775–1872), came to the area about 1800. They were farmers and owned vast acreage in and around present-day St. Matthews. William and Rachel were the parents of nine boys, several who banded together and once owned "tremendous farm holdings on both sides of Shelbyville Road."

City records show that on December 23, 1980 the City of St. Matthews purchased, from the Arterburn family, a parcel of Community Park property, being 13.3543 acres on which the current Arterburn building stands. The

land deed refers to the real estate as "commonly known as Arterburn Park."

Council minutes from 1981 include a decree by then Mayor Bowling, Sr. and City Council members to name the Community Center Building, Arterburn Hall, after the Arterburn family.

The original Community Center building was lost in a fire and the existing building was erected in 1982. City officials are not sure why the name fell by the wayside over the years, but it is their intent to restore the name that was decreed originally.

During recent Parks Committee meetings, the name Arterburn Hall was discussed, and it was the Parks Committee's recommendation that the name be shortened to The Arterburn, in the same style of names for other event venues such as The Olmstead.

Kenan Stratman, director of Public Works, says the venue was completely renovated in 2021-22. Studio Kremer was the architect firm, and Marrilla was the contractor for both exterior and interior renovations.

The exterior renovations include pergolas, a new patio, large sun sail, perimeter fencing, additional parking and new lighting.

Interior renovations include new LED lighting, ceiling, plank vinyl flooring, renovated kitchen and appliances, new AV equipment, renovated

bathrooms, new bridal dressing room with a private bathroom, and a new geothermal HVAC system.

### Chief Clark Initiates Department's Emergency Operations Center and Incident Management Team for Wind Event

Friday, March 3, 2023, started as a typical day around St. Matthews Fire and EMS with normal routines, training, and call volumes, but a storm was brewing in the background. The National Weather Service (NWS) was predicting a wind event behind a storm system that would be approaching the St. Matthews community around 3 pm.

It was one of the first weather-related events under the leadership of Chief Nick Clark. Chief Clark initiated the district's Incident Management Team (IMT). The mission of the IMT is to develop an Incident Action Plan (IAP) and to manage the fire district's resources during an operational period of time that experiences high call volumes. IMT staff are specifically trained through the Federal Emergency Management Agency (FEMA) and is required of all Chief Officers at St. Matthews Fire and EMS.

The IMT works from a central point within the fire district, the Emergency Operations Center (EOC), where they receive requests for service from Metro-Safe, assign fire and EMS units, and track the resources of the district.

The operational period for the wind event began at 3 pm and ended at midnight.

During this period, St. Matthews Fire and EMS responded to over seventy 911 calls for service, a structure fire on Hurstbourne Lane with Jeffersontown Fire and EMS, and a lengthy auto extrication on Blankenbaker Lane. A mutual-aid request was made for an extra Engine Company that was deployed from the Zoneton Fire Protection District in Bullitt County to assist St. Matthews fire units on the streets. St. Matthews Fire and EMS successfully responded to all calls of service within the district which largely entailed downed power lines and transformer fires.

Chief Clark's decision to deploy the IMT allowed district leadership to test the district's new Microsoft platforms for information sharing and communications. The use of modern cloud-based technology allowed the IMT staff to work seamlessly as they communicated the operational plan,

## A Message From...

### Cathi Clark replaces Stuart Monohan on City Council

City Council member Stuart Monohan, last re-elected in the 2022 General Election, has resigned from the City Council effective Feb 7, 2023, as he and his wife moved out of the city. Stuart served St. Matthews for 20 years, first taking office in January 2003. Stuart served as Parks Committee Chair for many years, working with other committee members to make improvement recommendations for all four of our city parks and various green spaces. In addition to serving on the City Council, Stuart is the Assistant Fire Chief for the St Matthews Fire Protection District.

Stuart, who was born and raised in St. Matthews, says that it was a difficult decision to move. He and his wife had property in Trimble County, and decided to downsize, and build a home there after spending most of their free time there. Stuart says, "I loved all of my twenty years serving the City on the council, and will continue to serve on the fire department."

Adhering to State of Kentucky election rules, the St. Matthews City Council was tasked with appointing a replacement to fill the open position within a 30 day period from the time the council seat was vacated. If not filled within 30 days, the Kentucky

governor has the ability to fill the seat with a person of his choice.

Stuart recommended that past City Council member Cathi Clark replace him on the Council. Cathi had finished in the 9th finish position in the 2022 General Election (top eight finish positions are elected for a two year term). Cathi stated, "I appreciate Stuart's confidence in me, and I am happy to be back on the Council. Insurance will be a huge hurdle in the upcoming year, and I bring the benefit of my background in insurance to the table to help find the most affordable solutions for the employees and taxpayers of St. Matthews."

At the next regular city council meeting on February 14, a motion was made, and approved, that the vacated seat on the city council be filled by Cathi Clark. Cathi was in attendance at the meeting and was sworn in by City Attorney John Singler that evening.

Election rules dictate that Cathi Clark serve as an appointed St. Matthews City Council member until the 2023 General Election in November, where her name must appear on the ballot, and be successfully voted in, to fill the remaining time of the two year term vacated by Stuart Monohan.

The 2023 General Election allows any person interested in serving on the City Council for the remaining time of the vacated city council position to register with the Jefferson County Clerk's office before Tuesday, June 6, and pay the \$50 registration fee to be placed on the ballot for the 2023 election. All City Council candidates must be at least 18 years of age, a resident of the city for not less than one year prior to the election, a qualified voter in the city, and shall reside in the city throughout their term of office. KRS 83A.040(4)

Stuart Monohan was recognized at the March 28 meeting by Mayor Tonini and City Councilmembers for his valuable and continuous service to the City.





A meeting of the St. Matthews Fire Protection District Board of Trustees took place on June 8, 2023, at the district's headquarters: 240 Sears Avenue, Louisville KY 40207.

Board members present were Chairman Rick Tonini, Secretary Kathy Wrigley, Treasurer Nick Heilmann, Trustee Mike Abell, Trustee Marshall Bradley via remote access, and Trustee Chris Mooser. Trustee Christine Kesler was unable to attend.

Also present were Chief Nicholas Clark, Assistant Chief Frank Flynn, Human Resource Manager Michael Frantz, Accountant Robin Roberts, Attorney Mark Leach, Major Greg Crabb, Major David Joels, Major Jeremy Leffler, Fire Marshal Stephen DunLany, Captain Brendan Montgomery, Captain Ryan Helton, Sergeant Gabor Greffer, Firefighter John Hatter, Firefighter Cameron Marshall, Firefighter Isiah Ramirez, and Administrative Assistant Terri Livers.

Chairman Rick Tonini called the meeting to order at 4:00 PM.

The minutes for the May 11, 2023, meeting were approved by motion of Secretary Kathy Wrigley. Second by Trustee Chris Mooser. Motion Carried.

**Treasurer's Report**

Accountant Robin Roberts referenced the Comments to Financials distributed with the board package. Both the profit and loss budget performance for the month and year to date were favorable. Rising costs of vehicle maintenance are being closely monitored, with increases attributed mostly to parts and labor. Approval of the May expenditures were motioned by Trustee Mike Abell. Second by Secretary Kathy Wrigley. Motion Carried.

**Old Business**

*Update of 2023 Trustee Appointment & Election* – Treasurer Heilmann reported on the upcoming election and the established dates for absentee ballots. Several members are scheduled to be on vacation during the week of the election on June 24, and have requested that additional opportunities for absentee ballots be expanded if possible. Attorney Mark Leach advised that the board could amend the bylaws for this upcoming election to allow for the addition. Motion by Trustee Abell, per discussion held by the board, to approve a variation in the schedule for absentee voting, for the 2023 election, only. Second by Secretary Kathy Wrigley. Motion Carried. The election committee will convene to decide on an updated schedule so that the information can be distributed to all our voting members.

## June 8, 2023, Trustee minutes

It was also shared that Trustee Christine Kesler would not be reappointed to the board for another term. Her financial expertise and dedication as a long-standing board member will be missed. Both Trustee Heilmann and Trustee Kesler were formally recognized for their service!

*Station 1 Bunk Room Construction* – Chief Clark reported that work will begin mid-July on the bunk room project. Plans are in place to move the dorm area out into the upstairs classroom space until construction is complete in 90 – 120 days.

#### **New Business**

*Preliminary Budget FY 2023-2024* – Chief Clark presented the recommended budget for FY 2023 – 2024 as re-distributed on May 17. Discussion held regarding reserve forecasting and the importance of maintaining pay scales comparable to the surrounding districts. The board approved a \$3,500 increase across the board for all employees, which amounts to at least a 7.9% increase for the lower pay scales. Motion of approval by Secretary Kathy Wrigley. Second by Trustee Mike Abell. Motion Carried. HR Director Mike Frantz and Assistant Chief Frank Flynn will be meeting with the fire districts after the new fiscal year to prepare a complete comparison of pay and benefits. That information will be shared with the board.

*FY 2022 / 2023 Audit* – Chief Clark reported that the district will be required to have an additional special audit of federal grant funds received in excess of \$750,000 – at a cost of \$15,000. The special audit will be performed at the same time as our regular year-end audit which will begin in August. A suggestion was made to pursue Request for Proposals for the FY 23/24 audit since we have used the same auditor for several years, although we have been very pleased with their thoroughness and work product. RFP's will be requested in January or February of 2024.

*Updated By Laws* – Motion of approval by Trustee Heilmann to approve the updated bylaws for the St. Matthews Fire Protection District, as prepared by Attorney Mark Leach. Second by Secretary Kathy Wrigley. Motion Carried.

#### **Fire & EMS Operation Report**

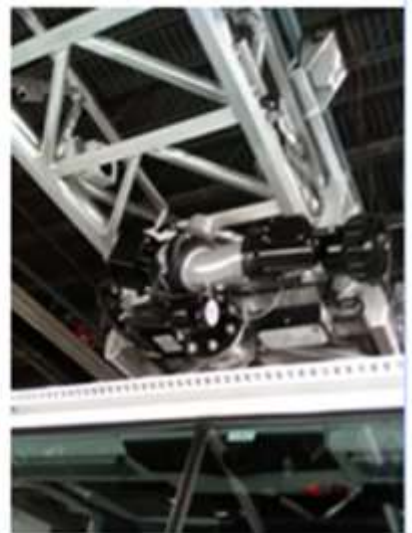

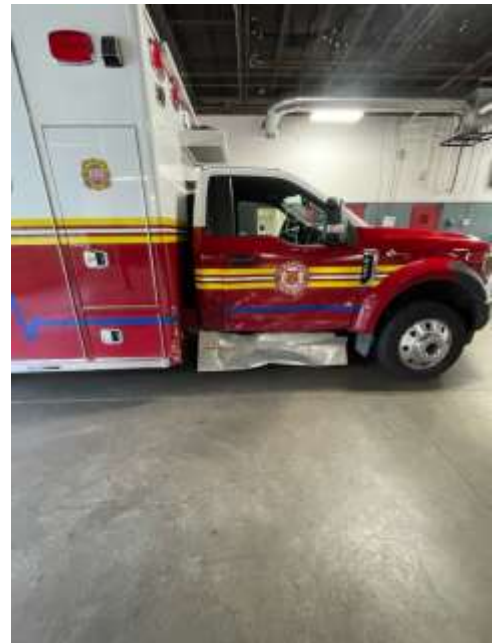

*EMS Statistics* – Assistant Chief Mike Riordan provided the statistics for June and detailed concerns with the number of responses (47%) that our units are making within the urban services district. We are working with the suburban fire districts and MetroSafe to identify problems with the new CAD and Louisville Metro's reduction of emergency medical service that they are providing to their constituents.

The 2023 Kentucky General Assembly heard, and is responding to service level complaints, with the development of a task force that will be offering local, listening committee meetings, for which we will have a voice along with the other suburban fire districts. Our fiduciary responsibility to the taxpayers of St. Matthews was stressed in this conversation. Assistant Chief Riordan will be in touch with Louisville Metro Council member Paula McCreary to discuss presenting at one of the committee meetings.



## UPDATE: Identity released of bicyclist struck, killed in Lyndon

LYNDON, Ky. (WAVE) - The bicyclist who died after a crash involving two vehicles in Lyndon has been identified.

According to the Jefferson County Coroner's Office, 39-year-old Rajan Sharma died from blunt force injuries sustained from the crash. His death is being ruled as an accident.

The Lyndon Police Department and St. Matthews Fire and Rescue were called to the intersection of LaGrange Road and Blue Vale Way on Tuesday just before 7:20 a.m.

Lyndon police said the bicyclist was pronounced dead at the scene. Both of the drivers reportedly stayed at the scene and were cooperative with police.

The Lyndon Police Department is still investigating the crash with the assistance of the Louisville Metro Police Department Traffic Unit.

**Executive Session**





## Eight Retire from Fire Department

What began in 1919 as a small volunteer fire department, St. Matthews Fire & EMS has grown into a fire district that covers 19 square miles with 4 firehouses and 99 employees. This past summer eight of those employees retired with a collective 200 years of active service. We would like to recognize these individuals for their dedicated service to our community and the Commonwealth.

**Assistant Chief David**

**Howser** retired on May 1, 2023, with over 42 years of service. David began volunteering with the Lyndon Fire Protection

District in 1980 and rose to the highest rank of Fire Chief. Chief Howser was instrumental in the merger of the St. Matthews and Lyndon Fire Protection District in 2017. In recognition of his proven leadership, he was named the Kentucky Fire Chief of the Year in 2018 by the Kentucky Association of Fire Chiefs.

**Major Patrick Montague** retired on June 1, 2023, with 27 years of service.

Patrick began as a volunteer in 1996 with the former Edgewood Fire Protection District, moving to St. Matthews in 2001.

Patrick was promoted to Sergeant in 2006, Captain in 2014, then Major in 2018. Some of Patrick's many accomplishments include his assistance in implementing the district's new EMS service in 2016, two unit citations for actions performed on the fire ground, recipient of the Fire Chief's Award in 2016, and induction into the Fairdale High School Hall of Fame in 2017.

**Captain Matt Board**

retired on August 1, 2023. Matt began as a volunteer in 1993 while also attending Eastern Kentucky University where he received a degree in Industrial Risk Management with an emphasis in Fire Science. He and his crew received the Firefighter of the Year Award in 1999. In 2000, Dan was promoted to Captain. Dan received two unit citations for actions performed on the fire ground.

**Hedden** retired on August 1, 2023. After volunteering with Camp Taylor and Lyndon Fire Protection Districts, Tommy hired full-time in 2001. Tommy would be promoted to Sergeant in 2013. Over his career, Tommy received several awards for actions performed on emergency scenes and was the recipient of a Certificate of Merit by the Louisville Metro Council for recognition of his service during the Katrina disaster in 2005.





LOUISVILLE, Ky. (WDRB) -- The westbound lanes of Interstate 64 are closed after a tanker truck hauling gasoline overturned and spilled thousands of gallons of fuel during the Wednesday morning rush hour.

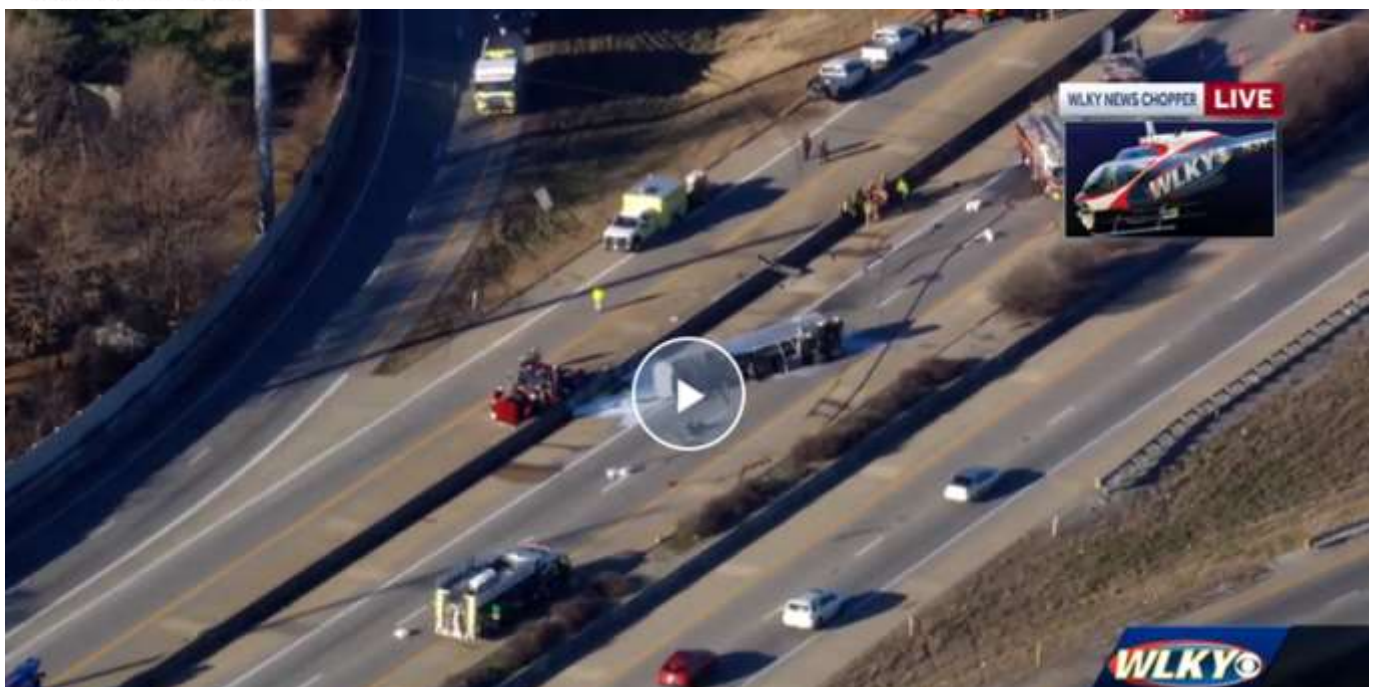
It happened around 8:20 a.m., according to a news release from Louisville Metro Police. That's when officers for LMPD's Eighth Division responded to a call for service on a semi tractor trailer tanker that had overturned on I-64 EB at the Watterson Expressway overpass.

The overturned tanker was leaking fuel and blocking all lanes of I-64 West. The tanker lost several thousand gallons of gasoline that will need to be cleaned up.

EMS responded to the scene to check out the driver, but there's no word yet on injuries. No other vehicles were involved. The cause of the crash is unknown at this time, but the LMPD Traffic Unit is investigating.

Traffic is being rerouted off I-64 onto Cannons Lane and the Watterson while crews attempt to clean up and upright the tanker. The on-ramp from the I-264 WB to I-64 EB and I-264 EB on ramp to I-64EB is closed as well due to this incident.

An overturned tractor trailer on I-64 East is causing major traffic delays Wednesday morning.



LOUISVILLE, Ky. — A major interstate in Louisville is shut down Wednesday morning due to a crash involving an overturned semi truck.

The overturned tractor trailer is blocking several lanes of I-64 East near the I-264 ramp in St. Matthews, crews are working to clear the vehicle out. Hazardous materials are present on the road.

It is unclear when the interstate will open back up or if there's any injuries resulting from the crash.

There is also an additional crash involving three vehicles on I-264 East near Breckenridge Lane that is causing traffic delays in the area.
